INVITATION OF EXPRESSION OF INTEREST (EOI) FOR SUPPLYING WITH FITTING FIXING OF 30W SOLAR LED STREET LIGHT OF ELECSSOL ALL IN ONE WITH 32 AH LI-ION BATTERY INCLUDING 6 METRE LENGTH OCTAGONAL POLE ETC. COMPLETE AT 09 NOS. OF SELECTED VILLAGES UNDER PRADHAN MANTRI ADARSH GRAM YOJANA (PMAGY) IN GOALPARA DISTRICT.

In cancellation of earlier Expression of Interest (EOI) floated vide this office NIT. No. GDG.53/2021/171-172 dated 01-12-2022, fresh "Expression of Interest (EOI)" is invited from reputed Firms/Suppliers/Authorized Dealers in plain paper affixing court fee stamp of Rs.8.25 (Non Judicial) for installation of Solar LED Street Lights at 09 Nos. of selected villages under PMAGY in Goalpara district as per approved specifications. The specification may be seen in the office of the undersigned during Office hours on all working days.

The interested parties may collect the EOI documents from the office of the Deputy Commissioner, Goalpara from 09/02/2023 to 16/02/2023 during the office hour for submission on payment of Rs.1000/-

(Rupees one thousand) only from this office.

SCOPE OF WORK: The scope of work shall include installation, testing and commissioning of Solar Street Light as per direction of department

EVALUATION CRITERIA: The evaluation of bids will be a two stage process:

Stage- 1: Technical Evaluation. Stage- 2: Financial Evaluation.

- FINAL EVALUATION OF THE BID :- The final selection of the bidder will be based on Quality & Cost based on selection.
- 2. PAYMENT SCHEDULE: The payment schedule is divided into two phases.
 - i) Implementation Phase.
 - ii) Maintenance Phase.

TERMS AND CONDITION :-

- 1. Earnest money of Rs. 5,000/- (Rupees- Five thousand) only has to be submitted in form of FD/Demand Draft/Bankers Cheque in favour of Deputy Commissioner, Goalpara along with the tender paper. This earnest money is refundable.
- 2. Rates should be inclusive of all taxes, installation charges, transportation charges etc.

3. The rate fixed shall remain valid for 1(one) year from the date of acceptance.

4. The Firms/Suppliers/Authorized Dealers shall mention the warranty period of minimum 02 years of the Solar Street Light as per Make/Brand standard.

5. At least 01 No. of similar work experience in Govt. Sector is mandatory and need to submit a single work order value of 80% of tender value. (For e.g. if tender value is Rs.1 Crore, one need to submit an order of Rs.80 Lakhs of single work order)

6. Quotations must be clear and should be completed in all respect.

- 7. The rates should be clearly quoted both in figures and against each item.
- 8. Quotationer must furnish the following self-attested document (up-to-date) along with the quotation.

a) Copy of GST registration Certificate.

b) Income Tax Clearance Certificate & Income Tax Return.

c) Copy of PAN Card.

d) Copy of Contractor/Farm/Vendor Registration (Electrical/MNRF) Registration.

e) Labour License/Trading License (if applicable).

Inferior quality product will not be accepted.

10. The undersigned is not bound to accept the lowest rates in a quotation and reserves the right to accept or reject any or all quotations without assigning reason thereof.

11. The Bidder should put his/her signature on all the documents.

12. The Firms/Suppliers/Authorized Dealers should mention the brands of the items of the Solar Street Lights to be provided during installation of the light compulsorily.

13. No payment will b made in advance for the installation.

14. The payment will be made after successful/satisfactory installation of the Solar Street lights.
