Sealed quotation affixing court fees of Rs.8.25 is hereby invited from the Registered Vehicle Scrapping Facility (RVSF) for disposal of condemned vehicles (**12 nos vehicles in one Lot, i.e 1 Lot = 12 nos vehicles**) under Health Deptt. Goalpara as per terms & condition mentioned below:

#### **Terms and Condition::**



1. Sealed envelope must described as "TENDER FOR DISPOSAL OF CONDEMNED VEHICLES" Under Health Deptt., Goalpara
- 1) The tender must accompany with earnest money at least @ 5% of the quoted value (Rounding off to the nearest zero in the form of Bank Draft in favour of. **DHS STATE FUND ACCOUNT, GOALPARA** The tenderer must write their Name/Address/Mobile No etc on the reverse side of the D.D)
- 2) Tender without court-fee stamp and earnest money shall summarily be rejected.
- 3) The vehicles will be disposed of "AS IS WHERE IS" basis. No demand will be entertained for any item not available in the vehicles.
- 4) The vehicle will be sold as LOT only. Bid for any individual vehicle will not be entertained/accepted.
- 5) The bid documents (**Annexure-A**) is attached herewith. The bid value must be quoted excluding G.S.T.
- 6) The Govt. reserved upset price is 30388/ (Thirty thousand three hundred eighty eight only)per vehicle. The bid value must be higher than the Govt. reserved upset price (Base Price).
- 7) The successful tenderer shall have to deposit the offered money after adjusting the earnest money in the form of Bank Draft in favour of **DHS STATE FUND ACCOUNT, GOALPARA** Within 7 (Seven) working days on receipt of acceptance letter issued from this end.
- 8) G.S.T. @ 18% (CGST 9% and SGST 9%) will be charged extra on the bid value which will have to be paid by the successful bidder and they are to produce the G.S.T. payment receipt to the O/o. Jt. DHS, Goalpara at the time of depositing the offered money.
- 9) On receipt of the full amount of offered money & G.S.T. payment receipt from the successful bidder; the lifting order will be issued by the Jt. DHS, Goalpara and deliver the vehicles. The successful bidder will have to remove the same within stipulated time fixed by the undersigned failing which the undersigned will not be responsible for any loss or damage of the vehicles.
- 10) The earnest money will be refunded to the unsuccessful tenderers only after the final settlement of the matter.
- 11) Tenderer may inspect the vehicles before submitting tenders on the locations mentioned (**Annexure-B**) in the list of condemned vehicles w.e.f publishing of the notification.

- 13) Incomplete tender will be rejected.
