

**Minutes of the meeting of District Development Committee, Goalpara held on 07-09- 2022  
from 11:30 AM in the Conference Hall of DC's Office, Goalpara**

**Members present- As per Annexure- A**

Shri Khanindra Choudhury, ACS, Deputy Commissioner, Goalpara presided over the meeting.

At the very outset, the Deputy Commissioner cum Chairman of DDC, Goalpara conveyed welcome to the all the members present in the meeting and took a short introduction of the Officials present in the meeting.

Thereafter, the Chairman of DDC, Goalpara reviewed the progress of all the schemes of different departments, discussed inter departmental issues and resolved as under-

**Health & Family Welfare**

1. The Joint Director of Health Services, Goalpara informed that the department has conducted 4 (four) Nos. of Post Flood Mega Health Camp under Lakhipur, Agia, Mornoi & Matia BPHC area and 1 (one) Special Health Check-up Camp has been conducted on 25-08-2022 at Nakalipara, Ramharir Char of Kharmuza MPHC under Agia BPHC.

2. The Joint Director of Health Services, Goalpara informed that awareness camp was conducted through miking and house to house visiting by ASHA, AWW and other Health Workers for precautionary dose of Covid-19 for 18 + age group. All Heads of Departments have been communicated to conduct special vaccination session and the task have been completed in most of the department.

In this regard the Chairman, DDC, Goalpara instructed the Inspector of Schools, Goalpara to co-operate with the Joint Director of Health Services, Goalpara for completion of precautionary dose for Covid-19 in the schools and colleges.

3. The Joint Director of Health Services, Goalpara informed the house that necessary measures have been taken to prevent Malaria Diseases and Hepatitis -B diseases throughout the district. He informed the house that 1 (one) dedicated treatment centre is functioning at District Hospital under National Viral Hepatitis Control Programme.

The Chairman DDC, Goalpara instructed the Joint Director, Health Services, Goalpara to take precautionary measures against Japanese Encephalitis in the district. Regular Health Check-up Camp to be organised throughout the district, the Chairman DDC, Goalpara stated. The Chairman DDC, Goalpara also instructed the Joint Director of Health Services, Goalpara to write separate letter to the Director of NHM, Assam to sort out the inter departmental issues.

4. The Joint Director of Health services, Goalpara as well as the Superintendent of Civil Hospital, Goalpara informed that most of the normal patients are being referred to the Civil

Hospital, Goalpara from the Sub-Divisional Civil Hospital, Lakhipur and PHE, Dudhnoi which creates overcrowding in the Civil Hospital, Goalpara as per capacity of accommodation.

The Chairman DDC, Goalpara instructed the Joint Director of Health Services, Goalpara to hold a meeting with the in-charge of both the Hospitals and ensure to accommodate the normal patients in their respective hospitals.

The Chairman instructed the Joint Director of Health Services, Goalpara to submit progress report in the next DDC meeting.

### **Handloom & Textile**

1. Asstt. Director, Handloom & Textile informed that the 8th National Handloom Day was celebrated in the office premises of Assistant Director of Handloom & Textiles, Goalpara. The Day was celebrated in presence of the weavers from SHG, Co-operative societies, Individuals and office staff.

2. Asstt. Director, Handloom & Textile informed that under SWANIRBHAR NAARI programme, the weavers of the district were being aware through departmental field staffs for registration of their names in the SWANIRBHAR NAARI portal. In this regards a meeting was held in the O/O the Deputy Commissioner, Goalpara on 16-08-2022 with the DPM, ASRLM, DPM NULM, BDOs of the district and BPM of ASRLM and 12603 Nos. Of weavers have registered their name through the portal and 5352 Nos. of application are verified by the departmental staffs till today.

3. Asstt. Director, Handloom & Textiles informed that under SAMARTH TRAINING PROGRAMME, 12 Nos. of trainee weavers have been undergoing 45 days of training programme in Handloom Training Centre, Goalpara.

4. The Asstt. Director, Handloom & Textiles informed that under the WEAVERS MUDRA SCHEME 30 (thirty) Nos. of proposal for MUDRA LOAN has been submitted to the various banks. Out of 30 Nos. of proposal, 10 Nos. have been sanctioned and 50% amount have been credited to the bank account of the weavers beneficiaries.

5. The Asstt. Director, Handloom & Textiles informed that 71 (Seventy one) numbers of beneficiaries have registered their names in Handloom Mark to exhibit and sale their products.

The Chairman, DDC, Goalpara instructed the Asstt. Director to submit progress report in the next DDC Meeting.

d. Under the activity for Beel Fisheries Demonstration, 2021-22, the physical achievement for Borjong Beel Development Management Committee is 75% and Gosaibari Bheri Bheri Beel Development Committee is 10%.

6. The DFDO, Goalpara informed that the following works are pending for construction of hygienic fish market, Goalpara as follows:

- a. The building roofs are not installed.
- b. The Office room and DG set room are not constructed at the top floor.
- c. The Gable wall at Back side of the building is not constructed, the parapet wall is not fully constructed in running length.
- d. Tiles work, painting work, rolling shutter, lavatory door frame, MS grill installation are not done.
- e. Flooring work is not done.
- f. Staircase plastering work and hand rail installation is to be completed.
- g. The electrification works are not installed.

The DFDO, Goalpara informed that the construction of Hygienic Fish Market at Goalpara will be completed by September, 2022.

The Chairman, DDC, Goalpara instructed the DFDO, Goalpara to resolve all issues relating to Hygienic Fish Market at Goalpara immediately so that the market can be inaugurated in September, 2022 positively.

The Chairman DDC, Goalpara also instructed the DFDO, Goalpara to expedite the works of all the schemes under Fishery Department to be completed within stipulated time period. The CO, Balijana Revenue Circle will submit detailed progress report in DDC next meeting as instructed in the last DDC meeting.

9. The Executive Engineer, PWD (Buildings), Goalpara informed that the work for construction of New Model Woman College at Jaleswar is in progress.
10. The Executive Engineer, PWD (Buildings), Goalpara informed that the work for construction of District Science Centre at Goalpara ( Package No. GMC-11 Nos. DSC) is in progress. The Contractor has been instructed for early completion of the work, the EE informed.
11. The Executive Engineer, PWD ( Buildings), Goalpara informed that the work for Construction of Dudhnoi IB, Dudhnoi, Goalpara (construction of care taker Qtr. at Dudhnoi IB), is in progress.

13. The Executive Engineer, PWD (Buildings), Goalpara informed that the work for construction of Kasturba Gandhii Balika Vidyalaya at Jaleswar HS School Campus is in progress.
14. The Executive Engineer, PWD (Buildings), Goalpara informed that the work for construction of RCC Office Building of Inspector of School GDC, Goalpara at Bhalukdubi, Goalpara is in progress and will be handed over by this month.
15. The Executive Engineer, PWD (Buildings), Goalpara informed that the work for construction of Sub-Centre at Khalsabhangha is in progress. The work withdrawn from the original contractor & re-allotted.
16. The Executive Engineer, PWD (Buildings), Goalpara informed that regarding the work for construction of labour room at Rajmita Sub-Centre under MsDP 12th Plan, as per application of contractor, the local miscreants are harassing the contractor and hence the contractor stopped the work. In this regard, the matter was pursue to the Deputy Commissioner, Goalpara vide this office letter No. TB-226/10-11/Pt-IV/ BLD/1024 dated 25-08-2022, he informed.
17. The Executive Engineer, PWD (Buildings), Goalpara informed that the construction of Anganwadi Kendra at Jyotinagar Moktab LP School under Molandubi GP under MSDP 12th Plan for the year 2017-18, the work is completed.
18. The Executive Engineer, PWD (Buildings), Goalpara informed that the work for construction of AWC at 141 No. Bualipara Tilapara to Pukhuri para AWC under MSDP 12th Plan for the year 2017-18, work stopped by the contractor due to pin point, changed order not given by concern Deptt.
19. The Executive Engineer, PWD (Buildings), Goalpara informed that the work for construction of AWC at Godhabori Muslimpara under Fofonga GP under MSDP 12th plan for the year 2017-18 is in progress.

2. The Executive Engineer, PHE, Goalpara informed that progress of JJM scheme implemented in Schools and AWCs as- Total No. of schools- 1650, AA Received-1338, Work order issued- 1337, work completed-1240 and Total No. of AWCs-1943, AA Received-1420, Work order issued- 1418, Work completed-1298.

The Chairman DDC, Goalpara instructed the Inspector of Schools, Goalpara as well as the District Social Welfare Officer, Goalpara to submit the list of Schools/ AWCs respectively to the Executive Engineer, PHE, Goalpara for taking necessary steps for implementation of JJM schemes.


