Minutes of the meeting of District Development Committee, Goalpara held on 18/11/2021 from 11.00 A.M in the  
Conference Hall of DC's Office, Goalpara

Members present- As per Annexure-I

Smti Meenakshi Das Nath, ACS, Deputy Commissioner, Goalpara presided over the meeting.

At the outset Deputy Commissioner cum Chairperson of DDC, Goalpara welcomed all the members present and initiated the discussion, point wise as per the agenda. As per directed from the chair, DDC, Goalpara read out the minutes of the last DDC meeting held on 24/02/2021.

The meeting reviewed the progress of schemes of different departments, discussed inter departmental issues and resolved as under-

Handloom & Textile :-

Asstt. Director, Handloom & Textile stated that 3824 nos. of Bank Passbook have been opened against the 3824 nos. of weavers and 50 nos. of looms (Tat Khal) have been distributed amongst the weavers. The Chairperson asked the Assistant Director, H & T, Goalpara to take necessary steps to make Assamese Gamocha available in the market.

Sericulture :-

- On being asked by the Chairperson, the Asstt. Director of Sericulture informed that few sericulture farms under Matia Revenue Circle are presently under encroachment. He will furnish the name of all such encroached farms in the next DDC meeting.
- The Chairperson also instructed the Asstt. Director of Sericulture to take necessary steps for erecting boundary wall of all the Sericulture farm in liaison with the PWD Building department. The matter will taken up with the Director of Sericulture from the end of Deputy Commissioner, Goalpara.
- Asstt. Director of Sericulture informed the house that maximum Sericulture Farms in Goalpara district are running without any manager. In this regard, the Asstt. Director will take up the matter with his higher authority.

Fishery :

- The house expressed its concern into the matter of slow progress of Hygienic Fish Market. DFDO will take necessary steps to improve the progress.
- DFDO, Goalpara will take immediate necessary steps for immediate constitution of District Level Co-ordination Committee for KCC in Fishery as per Govt. directions/guidelines.

PWD(B) :-

- The Chairperson instructed EE, PWD (B) to complete all the pending works of the Anganwadi Centers within the timeline. The EE, PWD(B) assures that he will try to complete the work by March, 2022
- It is raised that there is land dispute in respect of construction Anganwadi centre at Molandubi GP Office, Krishnai Dev. Block under Matia Revenue Circle. The Chairperson instructed CO, Matia to verify land issue and will submit report.
- The EE, PWD(B) elaborated about the status of the schemes like Construction of Auditorium Hall, Construction of Model School at Kuchdhowa, Construction of Sports Complex etc. DC instructed to make speedy progress of the old schemes in the district.
- The Chairperson took stock the progress status of the work of Woman College. EE, PWD(B) said that the work has already been started and is likely to complete within the time limit.
- The Chairperson also instructed to complete the work of construction of ICU at Civil Hospital, Goalpara immediately.
- EE, PWD(B) apprised the house that the work of ANM Nursing Training Institute is running and will be completed soon.

PWD(NH) :-

- The house discussed about the status of work of Krishnai Bridge. Chairperson instructed to complete the work soon for the greater interest of public. EE, PWD(NH) assured the house to complete the said work by June, 2022.
- EE, PWD(B) informed the house that the work i.e. i) Paikan-Baijongdoba & ii) Amjonga to Dudhnoi will be started soon.

PWD(RR) :-

- EE, PWD (RR) will ensure completion of construction works in respect of 4 Nos. Bridges for the year 2017-2018 by March, 2022.
- EE, PWD (RR) informed that 26 schemes are running in Goalpara district. He assured the house to complete the ongoing works by March, 2022.
- The Chairperson instructed all HODs to submit status report about the schemes running under RIDF Scheme in the next DDC meeting.
- The EE, PWD(RR) informed the house about the schemes under NABARD i.e. i) Construction of Road at Sildubi ii) Construction of Harimura to Krishnai Road & iii) Improvement of Lakhipur Jaleswar Road. He informed that 02 bridges have been sanctioned in the 39-Jaleswar LAC. The Chairperson instructed EE, PWD (RR) to make speedy progress of all the works pertaining to his department.

Education :-

- The Chairperson stated that all the students and teachers are found absent in two nos. schools during her sudden visit. She requested all HoDs to make sudden visit to at least 03-04 schools in a month and take stock of few area viz. (i) School environment (ii) Health & hygiene & (iii) Cleanliness and to make interaction directly with the students and will hold discussion with the Head Teacher about the anomalies/shortcoming found during their visit. The HoD will ensure to visit the schools, once in a month as per his/her convenience, take a class on GK, social affairs & interact with the students and report as per format by months end regularly.

Water Resource :-

The ongoing works of WR Deptt has been reviewed. The Chairperson will visit and inspect two nos. schemes of WR department namely (1) Anti Erosion Measure of river Dudhnoi at Salbari area and (2) Immediate measures to recoup of marginal bundh from Dudhnoi to Nandeswar, 2020-2021

Irrigation :-

EE, Irrigation informed the house that in the year 2019-2020, no new schemes under Irrigation Department in Goalpara district has been launched. Few old schemes are partially in defunct condition. Deputy Commissioner instructed to submit the list of such partially defunct schemes.

Health :-

- The Chairperson asked the Joint Director of Health Services about the status of Covid-19 in the district and the plan for containment zone relating to the pandemic. He informed that till 18-11-2021, 96.2% vaccination has been done.
- Deputy Commissioner suggested all the HODs to ensure wearing of mask by all officials during the time of pandemic.
- She also suggested all HoDs to ask the beneficiaries of their departmental schemes to produce Vaccination Card during the time of submission of application for any scheme.
- The Chairperson asked Joint Director of Health Services to increase the COVID testing centre in the district.

DICC :-

General Manager, DICC, Goalpara informed the house that at present 156 nos. of applications under PMEGP scheme have been received out of which 150 nos. are disposed.

Deputy Commissioner suggested to complete the target within the time frame. The GM requested the house to make allotment of at least 100 Bighas of land for making industrial park. The Chairperson opined that the required land may be identified in the Lakhipur area.



District Transport :-

The Chairperson asked the DTO about the status of E-Rickshaws running in the district. She also asked about the nos. of E-Rickshaws running in the town and instructed the DTO to make it systematic. She instructed DTO to look into the matter as follows :-

1. To execute " No Helmet No Oil" in the petrol pump within next 15 days.
2. To stop Registration Process of e-Rickshaws in the district.
3. To normalize the E-Rickshaws in the district in liaison with the Addl. Superintendent of Police, Goalpara.

Further, the house resolved to arrange a meeting with Superintendent of Police, Goalpara, Executive Officer, Goalpara Municipal Board, Chief Executive Officer, Zilla Parishad, Goalpara, District Transport Officer, Goalpara with regard to controlling of e-Rickshaws in the district.

GMB

The Executive Officer, GMB will verify the number of e-Rickshaws running in Goalpara town and will prepare route map of E-Rickshaws in the town. EO, GMB will take necessary steps against the e-Rickshaws which are running without valid permit.

Social Forestry :-

- The Chairperson suggested DFO (SF) to take up new schemes. She requested DFO(SF) to explore a feasible mechanism to sort out elephant depredation issues in the district. In this respect, the Chairperson opined that plantation of consumable tree saplings may solve the issue upto some extent.
- Shri Pallav Jyoti Nath, Addl Deputy Commissioner, Goalpara asked about the status of Dubapara Park. DFO (SF) replied that estimate has already been submitted to the concerned department. DFO(SF) will pursue the matter.

APDCL:-


- Addl. CM & HO reported that APDCL officials disconnected the electricity connection in her office without prior notice causing disruption in emergency services. The Chairperson requested AGM, APDCL not to make any disconnection without prior information to the offices dealing with emergency services.

In her concluding speech the Chairperson requested all concerned to take necessary steps for completion of all the ongoing schemes, pending tasks etc. in convergence manner within the stipulated time line.

This meeting ended with a vote of thanks from the chair.
