The last date of lifting of the allotted rice for the month of FEBRUARY, 2023 is 31-01-2023. The allotted rice is to be distributed PHH RC @ 5.00 Kg per head per month and AAY RC @ 35.00 Kg per RC per month at free of cost. Shri S N Sarma Traders, Transporter of Tier-I & Tier-II vide this order No. GSG-03/2017/294-297 dated 13-08-2019 to ensure door step delivery of rice under NFSA -13 on receive of release order from the Secretaries of respective GPSS/WCCS etc. to be issued by FCI Bongaigaon.
