

Minutes of the meeting with representatives of Political Parties of Goalpara Election District on publication of integrated & amalgamated draft Electoral Roll w.r.t. 01-01-2024 as the qualifying date held on 08/12/2023 at 4:30 PM in the Conference Hall, DC's office, Goalpara

Members Present: As per "Annexure –A"

The meeting was presided over by Shri Khanindra Choudhury, IAS, Deputy Commissioner & District Election Officer, Goalpara. At the outset, the Chairman welcomed all the members present in the meeting and initiated the discussion.

With due permission of the Chairman, Election Officer, Goalpara briefed the purpose of the meeting and apprised the house about the publication of integrated & amalgamated draft Electoral Roll w.r.t. 01-01-2024 as the qualifying date.

After threadbare discussion, the meeting has resolved as under :

1. The Chairman requested all members to witness the publication of integrated & amalgamated draft Electoral Roll (w.r.t. 01-01-2024 as the qualifying date) and accordingly the same has been published in the house i.e., on 8th December, 2023.
2. The Chairman informed the house that the said draft electoral roll has also been published at the Website of District Administration, Goalpara so that public can access the same.
3. The Chairman shared data related to LAC wise number of Polling Stations, Electors details as per Draft Roll published in respect of all four nos. newly delimited assembly constituencies as below :

LAC wise number of Polling Stations :

(a) 12-Jaleswar LAC	=	249 Nos.
(b) 13-Goalpara West (ST) LAC	=	189 Nos.
(c) 14-Goalpara East LAC	=	249 Nos.
(d) 15-Dudhnoi (ST) LAC	=	223 Nos.

LAC wise total electors :

(a) 12-Jaleswar LAC	=	225077 (Male: 115419, Female-109656, TG-02)
(b) 13-Goalpara West (ST) LAC	=	155624 (Male: 77434, Female-78185, TG-05)
(c) 14-Goalpara East LAC	=	213989 (Male: 107027, Female-106959, TG-03)
(d) 15-Dudhnoi (ST) LAC	=	174179 (Male: 84697, Female-89479, TG-03)
Goalpara District Total	=	768869 (Male: 384577, Female-384279, TG-13)

4. It is also requested from the Chair to analyse LAC wise data of female electors so that Male-Female ratio could be balanced and no eligible female voter is left out.
5. It is resolved that Special campaigns will be launched throughout the district for all newly eligible citizens to get them enrolled in the Electoral Rolls. Accordingly, Election Officer, Goalpara informed the house about the Special Campaign plan.
6. EROs, AEROs and BLOs will take appropriate steps on Absent/Shifted/Dead (ASD) of their respective part to improve the health parameters of the Electoral Roll and ensure deletion of all ineligible voters. They will analyse the data of voters age group 18-19 years as per Census data.

7. It is resolved that all eligible citizens amongst 18-19 years age group in all Govt. and Non-Govt. Educational Institutions are to be covered through Dedicated AEROs so that state average can be achieved.
8. Mr. Abdul Hai, Representative of AIUDF, Goalpara informed that few anomalies are there in the title page of Electoral Rolls. Accordingly, Election Officer, Goalpara assured him that the reported anomalies will be sorted out during this SSR period.
9. Mr. Noni Kr. Das, representative of CPI(M), Goalpara informed the house that no new EPIC is issued as per newly delimited assembly constituencies and asked whether existing EPICs will be considered as valid document for casting vote during Poll Day. In reply, it is clarified from the Chair that the information in this regard will be communicated as and when it is received from the Commission.
10. The Chairman requested all the representatives of Political Parties for immediate engagement of BLA.

Finally, the Chairman appealed all the members to extend their active cooperation to achieve 100% registration of new eligible voters in the district within stipulated time limit.

The meeting ended with vote of thanks from the Chair.
