ORDER

Whereas, the Election Commission of India, vide Press Note No. ECI/PN/029/2026 dated 15th March, 2026, has declared the schedule for the General Elections to the Assam Legislative Assembly, 2026, and the date of poll has been fixed as 09-04-2026;

And whereas, the Model Code of Conduct is in force and is required to be strictly observed by all political parties, candidates, and other stakeholders;


And whereas, as per the provisions of Section 126 of the Representation of the People Act, 1951, and the instructions issued by the Election Commission of India, campaigning by political parties and candidates must cease 48 (forty-eight) hours prior to the hour fixed for the conclusion of poll in the constituency;

Now, therefore, I, **Prodip Timung, ACS, District Magistrate, Goalpara**, in exercise of the powers conferred upon me under the **Representation of the People Act, 1951**, and in pursuance of the directions of the Election Commission of India, do hereby order as follows:

1. All forms of election campaigning, including public meetings, processions, rallies, road shows, door-to-door canvassing, and propaganda through print or electronic media, shall cease with effect **from 05:00 PM on 07th April 2026** and shall remain prohibited **until the conclusion of polling** in the respective Assembly Constituencies of Goalpara district **on 09th April 2026**.
2. No political function, campaign activity, or election-related public gathering or meeting shall be permitted during the "Silence Period."
3. The use of loudspeakers, public address systems, or any other means of sound amplification for election campaigning purposes is strictly prohibited during the "Silence Period."
4. Display or propagation of any election-related matter through television, cinema, radio, social media platforms, bulk SMS, WhatsApp messages, websites, or any other electronic or print mode, with the intent to influence voters, is strictly prohibited during the "Silence Period."
5. All campaign offices shall remain closed during the "Silence Period." No unauthorized gathering or election-related activity of any kind shall take place at or near such offices.
6. All persons who are not electors of the concerned constituency shall leave the constituency before 05:00 PM on 07 April 2026.
7. Any violation of this order shall invite strict legal action under the Representation of the People Act, 1951, the Bharatiya Nyaya Sanhita, 2023 (BNS), the Bharatiya Nagarik Suraksha Sanhita, 2023 (BNSS), and other applicable laws in force.

This order shall come into force with immediate effect and shall remain in force until the completion of polling and announcement of results in the district, or until further orders, whichever is earlier.


