**ORDER**  
**(U/S 144 Cr.P.C.)**

Whereas, the District & Session Judge, Goalpara vide letter No. DJG/2159 Dated 22/05/2024 requested for issuance of order regarding declaration of “No Fly Zone” over the Court premises of District Judiciary, Goalpara to improve the security arrangement of the court premises.


Whereas, in view of the emerging new security threats due to recent trends of carrying out drones as improvised explosive device by anti-social elements, it is imperative to strengthen the security measures in the district court premises for safe and secure and smooth conduct of the court proceedings. Keeping this in mind, it has become necessary to issue no fly zone orders in the court premises of District Judiciary, Goalpara.

Now, therefore, I, Shri Khanindra Choudhury, IAS, District Magistrate, Goalpara in exercise of the powers vested upon me under Section 144 of the CrPC with a view to ensure proper security, do hereby declare the area of court premises of District Judiciary, Goalpara as “No Fly Zone”. Flying of any kind of aviation devices including Unmanned Aerial Vehicles (UAVs), Drones, Balloons etc. in this area will be strictly prohibited.

**This order shall come into force with immediate effect and remain in force till 30/11/2024.**

**The Superintendent of Police, Goalpara shall ensure implementation of this order in letter and spirit.**


