ORDER


Whereas, the information received from the Indian Meteorological Department (IMD), Regional Meteorological Centre, Guwahati regarding isolated extremely heavy rainfall warning for the state including Goalpara district causing damages to lives and properties in the district of Goalpara.

Whereas, rains are also likely to be accompanied with severe cyclonic storm.

Therefore, in the greater interest of public, I, Shri Meenakshi Das Nath, ACS, District Magistrate, Goalpara in exercise of power conferred upon me **U/S 144 Cr.P.C.**, do hereby promulgate prohibitory order banning of fishing / sailing of country boats / ferry services / engine boats (Bhutbhuti) in the river Brahmaputra, Dudhnoi, Jinari and Krishnai and other tributaries in the district with immediate effect from 20th June, 2022 until further order.

Considering the above facts and circumstances, immediate prevention and speedy remedy is desirable to save the lives and properties, the order is passed ex-parte. This order comes into force with immediate effect.
