II ORDER II

U/S 163 BNSS

Whereas, the Circle Officer, Matia Revenue Circle, Matia was entrusted to enquire into the public complaint regarding deplorable condition of the Nepalikhuti to Krishnai PWD Road.

Whereas, the Circle Officer, Matia Revenue Circle, Matia vide letter No. MC.06/Misc/2024/422 dated 20/07/2024 submitted a report wherein it is mentioned that heavy over loaded vehicles above 10 (ten) tons are plying regularly on the road mainly sand carrying dumpers from the nearby sand mahals leading to its deterioration as well as creating nuisance to the public including traffic congestion.

Whereas, the Executive Engineer, PWRD, Goalpara East & Jaleswar Territorial Road Division, Goalpara vide letter No.GLP/GE&J/TRD/TB/Misc-Pt-IV/2024-25/1092 dated 20/07/2024 informed that the load capacity of the Nepalikhuti to Krishnai PWD Road is maximum 10 (ten) Tonnes.

Now, therefore, I, Shri Khanindra Choudhury, IAS, District Magistrate, Goalpara in exercise of the powers vested upon me under Section 163 of the BNSS with a view to prevent damage of Nepalikhuti to Krishnai PWD and also to ensure proper safety and security of public life and property, do hereby prohibit plying of overloaded vehicles carrying more than 10 (ten) Tonnes in the road.

This order shall come into force with immediate effect until further orders.
