
1. The Printing Press should be registered with Printing & Stationery Deptt. Government of Assam (supported by copy of Registration.
2. The rates quoted should not be more than the rates fixed by the Director, Printing & Stationeries, Assam vide his letter No. DPS/PTG (E) 42/2020/65 Dated 28/10/2022 i.e. for both side printing Rs. 2.80 ( per copy ) & single side printing Rs. 1.90 ( per copy).
- 3 The rate should be quoted inclusive of cost of delivery to the Election Branch, DC,s Office, Goalpara.
4. The rate should be quoted in both figures and words.
5. The rate should be quoted inclusive of GST.
- 6 The rate should be quoted inclusive of supply of papers.
