No.TMV/E-194696/97: Whereas the "Vehicle Scrapage Policy of Assam, 2022" was notified vide Notification No. TMV.72/2022/39, dated 18th July, 2022 with a provision to launch an "One Time Settlement" scheme to incentivize voluntary scrapping of old and unfit vehicles and in pursuance of the same, the Governor of Assam notified a One Time Settlement (OTS) scheme vide notification No.E-194696/50, dated 12th January, 2023 effective for a period of 1 (one) year w.e.f. 15th January 2023.

As per the Scheme, on voluntary offer of a vehicle to a Registered Vehicle Scrapping Facility (RVSF) for scrapping, 75% of the total outstanding arrear dues/liabilities (MV tax, fitness fine etc.) against the vehicle shall be waived off.

Now, in pursuance of the directives of the Ministry of Road Transport and Highways vide letter no. RT-23013/4/2021-T, dated. 19th June, 2024 regarding extension of one-time waiver of liabilities on vehicles scrapped at RVSFs in Assam and in exercise of the power's conferred on the State Government by Section 3 of the Assam Motor Vehicle Taxation Act 1936 and Section 65(2)(h) of the Motor Vehicle Act 1988, the Governor of Assam is pleased to notify an extension of one-time waiver of pending liabilities on vehicles scrapped at RVSFs in Assam.

The one time settlement scheme which was earlier extended till 31st March, 2025 vide Notification eCF No.194696/81 dated 28th June, 2024 is further **extended and shall be effective till 31st March 2026.**

Sir,


I am directed to State that Ministry of Road Transport and Highways (MoRTH) has introduced Voluntary Vehicle-Fleet Modernization Program (V-VMP) or "Vehicle Scrapping Policy" aimed at creating an eco-system to phase out unfit and polluting vehicles in an eco-friendly manner.

2. As part of the policy, States were advised to provide one-time waiver of pending liabilities (e.g., pending taxes and fee related to insurance, registration etc.) on vehicles scrapped at RVSFs for a period of at least one year vide MoRTH letter no. RT-23013/1/2022-T dated 21st November 2022. In this regard, Assam Government notified such an exemption vide Notification No. E-194696/50, dated 12 January 2023, effective for a period of 1 year, w.e.f. 15 January 2023 to 14 January 2024.

3. However, exemption under the said notification was implemented on Vahan only in August 2023, resulting in benefit to citizens for only 4-5 months. Further, recognizing that the implementation of vehicle scrapping policy is still in its formative stages, the State is requested to extend one-time waiver of pending liabilities for at least two more years, i.e., until March 2026.

4. It is requested that an early action may be taken in this regard.
