**General Terms and Conditions:**

1. The tender sale be received only through online up to 05:00 PM (IST) on 12-11-2023.
2. The tender will be opened on the 14-11-2023 at 10:00 AM (IST). If this office does not function on the above day for any reason beyond control, tender will be opened in the next working day.
3. E-Tender should be submitted with requisite court fee stamp of Rs. 8.25/- as per Annexure-I for each lot even if the same bidder bids for several lots.
4. The tenderers shall pay documents fee of Rs.60/- for each lot.
5. The tenderer belonging to any schedule cast, schedule tribe or other backward classes will require to deposit 10% of the Earnest Money.
6. The tenderer should offer their bids only after personally inspecting the timber lot and fully satisfying themselves regarding availability of extraction path and quality of timbers. The Department shall not take any responsibility in this regard and no complaint whatever in this respect shall be entertained later on.
7. The successful bidder shall pay the GST, Income Tax etc. in addition to the offered price as per prescribed rate.
8. The authority making settlement shall have the discretion to refuse settlement to a bidder who is defaulter in respect of Forest Revenue in any Forest Division in Assam.
9. There is no obligation on part of the authority making settlement to accept highest tender or to assign any reason for rejection of any tender. Authority may cancel the tender at any time without assigning any reason thereof.
10. Canvassing directly or indirectly by any bidder will attract penalty of disqualification.
11. The bidders will get 7 (Seven) days for appeal period from the date of issue of the provisional settlement of lots.
12. The bidders will get 15 (Fifteen) days for depositing bid value i.e. Royalty, GST and Income Tax etc. after issue of final settlement of lots.
13. The bidder shall arrange to lift the timber lot from the depot within 15 (Fifteen) days from the date of receiving of the lifting order. No complaint whatever will be entertained thereafter. Any other information regarding details of the timber lots may be obtained from office of the undersigned during office hours on any working days.
14. The tenderer has to register in the web portal [www.assamforestonline.in](https://www.assamforestonline.in) to participate in E-Tender process and has to submit the necessary documents required for bidding in the E-Tender process.
15. All other terms and condition laid down in the "Assam Sale of Forest Produces, Coupes and Mahal Rules, 1977" and "Assam Sale of Forest Produces, Coupes and Mahal (Amended) Rules, 2000" shall be applicable for disposal of the tenderers.
16. The following documents must be submitted through online during the time of bid submission.
  - a) The tenderer must deposit earnest money of the respective lot through online and upload EMD Receipt.



- b) Copy of PAN Card.
- c) Copy of ID Proof (Aadhar Card/Voter ID/Passport/Certified copy of Electoral Roll).
